> Citizen Comments on Non-Agenda Items:

The Clerk read the statement regarding decorum for those scheduled to speak. The speakers shared the following:

- o Travis McKinney A better way to spend \$27 million. Mr. McKinney did not agree with the way the division was spending money. He also does not agree with virtual learning as it is a failure.
- o Jaer Ashan Anderson The use of the appointed \$11 million from the 27 million dollars associated with the ARP/ESSR II funds; to help encourage tutoring provided by a select group of college students who are majoring in early education or teaching to help with the "SPS" educational program. Mr. Anderson suggested that the money be spent on academic tutoring programs and socio emotional learning.
- O Desmond Rawls KFHS Marching Band & other activities. Mr. Rawls was upset that 7th grade students in middle schools are no longer able to participate in the marching band and other high school activities.
- o Kirstyn O'Neill Pod Squad, a program we developed at NSES. Parents from NSES were thinking outside of the box and created the Pod Squad. This squad is a revolving list of volunteers who help out in the cafeteria on a daily basis. Whether it be for five minutes or an hour, those volunteers are welcomed.

Board Member Riddick provided clarification regarding 7th grade students participating in high school activities and indicated that Dr. Gordon will be back in touch with follow-up information.

BUSINESS BY BOARD MEMBERS

> Comments and Reports by School Board Members:

Board Members thanked Board Chair Riddick for his leadership, the constituents for allowing members to serve, and for attending the meeting and for providing a voice to the division. Members also congratulated Dr. Gordon for being selected by the National School Public Relations Association as a 2022 Superintendent to Watch. Board Members thanked Dr. Gordon for putting SPS on the national stage, for moving the division forward in the right direction, and for thinking outside of the box.
