OPENING OF PUBLIC MEETING/WORK SESSION

Call to Order:

The meeting was called to order at 6:00 p.m. by Dr. John B. Gordon III, Division Superintendent.

> Pledge of Allegiance:

Dr. Gordon led all in reciting the Pledge of Allegiance.

The moment of silence and recital of the SPS mission were not observed at the organizational meeting.

Abstain: 1 (Riddick). The vote was tied, 3 to 3 to 1.

Dr. Gordon recessed the meeting at 6:04 p.m. for five (5) minutes.

Dr. Gordon called the meeting back to order at 6:09 p.m., opening with a discussion session for Board Members. Board Members shared reasons for their support of Board Members Howell and Jenkins for the position of Chairperson.

There being no further discussion, Dr. Gordon asked for nominations for School Board Chair.

Board Member Dr. Brittingham nominated Board Member Howell. Board Member Byrum nominated Board Member Jenkins.

Chair Jenkins named Board Member Heather Howell as Vice-Chair.

Appointment of Clerk and Deputy Clerk through December 31, 2024
