Subject: Addendum #3,-1737 P

Session Initiated Protocol (SIP) Trunk and Transport

Question: Are we to assume that the circuits at E. Wash & King's Fork are to have sufficient capacity to handle Data in addition to SIP traffic? Or, will these circuits be expressly used for SIP?

Answer: No, as part of the proposal transport circuits need to be included.

Question: Regarding E. Wash & King's Fork, if circuits are to be used for both Data & SIP, what is the total bandwidth needed for Data traffic?

Answer: Circuits for SIP are to be included as part of the proposal. Our data needs are served by different paths.

Question: We understand the request for 115 call paths and that both sites are to have equal share in the load (50% minimum capacity), but how many call paths are actually used during Peak Traffic Times; all sites included?

Answer: This is difficult to estimate but the 115 call paths have been adequate for our needs.

Question: Can the (2) Circuits referenced (for E. Washington and King's Fork) be delivered as Internet, rather than MPLS or "private lines")? No other reference is made to MPLS elsewhere in the network

Answer: Not sure what is being asked

Question: If Internet (see 3 above), are we to understand that SPS can and will encrypt the data-traffic, creating their own VPN, while allowing SIP traffic to pass, unencrypted?

Answer: Not applicable

Question: What is the total "MoU" Minutes of Use, for the entire SPS enterprise, in a busy month?

Answer: This data is not available
