Engineered Wood Fiber Safety Surfacing April 27, 2021

Terms of the agreement:

The initial term of this agreement shall begin on July 1, 2021 and will continue through June 30, 2022. This contract will be automatically renewed each year for four (4) additional one-year periods, beginning on July 1st and ending on June 30th of each subsequent year unless otherwise terminated by either party by giving written notice prior to May 31st of each year. The School Board may approve a price increase for each subsequent year. This request shall be presented in writing by April 1st of each year and the cost increases shall not exceed the Consumer Price Index (CPI) as developed by the Bureau of Labor Statistics U S. Department of Labor, for all Urban Consumers (CPI-U) south, for the preceding calendar year.

It is mutually agreed that parties may agree to extend additional time to the end of the contract to ensure a continuity of services during the rebidding process, if necessary.

The contractor shall be responsible for initiating, maintaining and supervising all required safety precautions and programs in connection with the delivery of safety surfacing.

It is mutually agreed that orders will be delivered in three business days.

The School Board reserves the right to purchase additional mulch/surfacing as needed to meet school operational needs.

The contractor will provide safety surfacing that is compliant to ASTM F1292 standards and will provide product that meets all of the requirements described in the Public Playground Safety Handbook published by the US Consumer Product Safety Commission.
