- **Federal Program Monitoring**
 - focuses on continuous program improvement and student achievement.
 - designed to assess school divisions' compliance with regulations, standards, and state and federal laws.

- Consists of three phases
 - **Phase I** – requires school divisions, on a six-year cycle, to conduct a comprehensive [CTE self-assessment](#) and develop a program improvement plan, as needed, to address identified deficiencies and concerns.
 - **Phase II** – requires the VDOE to conduct an analysis of the self-assessment report and other relevant data as well as an on-site monitoring review.
 - **Phase III** – requires school divisions to correct any identified deficiencies and concerns.
